### **Expo Instructions**

1. Booths must be set up by 9:30 a.m. on Saturday, March 18, 2017 and must remain open until 5 p.m.
2. Booth spaces will be allocated on a first-come/first-served basis. Reservations will be confirmed upon receipt of contract and payment.
3. All booth fees are non-refundable and due two weeks prior to the event. Modesto Marathon will try to honor booth location requests; however, we reserve the right to make reasonable changes to requests as space is limited.
4. Vendors may not sublet booths.
5. The Modesto Marathon reserves the right to reject a vendor booth.
6. Based on California excise tax rules and California State laws, the City of Modesto requires that every vendor have City of Modesto Business license. If vendor does not have a City of Modesto Business license, vendor will be required to purchase a one-day City of Modesto itinerant business license. The fee is \$10. Modesto Marathon will provide paperwork necessary for this itinerant license.
7. Vendors are allowed to use display systems, however, fire code prohibits the use of canopy coverings.
8. Food service must be previously arranged with the Modesto Marathon and requires special county food service permits.
9. The Modesto Marathon is not responsible for lost, stolen or damaged merchandise.
10. Vendors may display signs or materials, however, they may not extend beyond booth boundaries.
11. Vendors may not damage the Modesto Centre Plaza. To hang a sign or banner on the wall above your booth (more than 8 feet high) will require an additional fee and must be specified in advance.
12. WiFi is not provided. WiFi must be arranged and paid at the time of booth request. Fees are \$75 per connection.
13. Modesto Marathon and Teens Run Modesto reserve the right to use any video, audio, or any photographic media obtained at the event for promotional purposes.
